EXTRAORDINARY GENERAL MEETING ON 12 MARCH 2014

An Extraordinary General Meeting was held in URS's Office on 12 March 2014 at which the following resolutions were voted on and passed.

Ordinary Resolution

In order to lower the entry barrier for small and medium Enterprises to join the Association, this resolution has confirmed that under Article 6(B) a member firm only need have one Consulting Engineer.

Special Resolution

Article 5B(1) has been amended to include the position of Vice Chairman of the Association who will essentially act as Chairman in the absence of the Chairman.

Article 64 has also been amended to clarify the established practices regarding retiring from the Council and the maximum term of office on the Council.

FUTURE SEMINARS / WORKSHOP

A seminar on the use of BIM in our industry is being planned. Suggestions from members on other topics would be welcome.

MATTERS OF THE MOMENT

Hong Kong has a poor record on site safety and there are no obvious signs of improvement. This year in Q1 there have been 10 fatalities on construction sites, which compares with an average of some 27 per year in the past few years. With this sombre statistic as a backdrop, I was invited to represent ACEHK at a CEO Round Table Forum on Safety in April 2014. This was convened by Thomas Ho of the HK Contractor's Association, and co-organised by Development Bureau, Labour Department and the Construction Industry Council. As consulting engineers I believe we all have a key role and indeed obligation to produce designs that can be safely implemented on site. Let's play our part in addressing the unacceptable level of fatalities on Hong Kong construction sites.

SEMINAR – DEVELOPMENT BUREAU TECHNICAL CIRCULAR 6/2013

ACE, and in particular its past-Chairman Alan Man, worked closely with Development Bureau in the preparation of TC 6/2013 with the aim of eliminating unreasonably low bids and requiring that proposals be based on appropriate rates and manpower inputs.

A number of actual bids have been submitted and assessed on this basis and the seminar was held to explain the process to members, review the results from these initial bids and to obtain feedback from members.

The seminar / workshop on 24 March 2014 was attended by approximately 40 staff from ACE member firms. Alan chaired the seminar and a copy of his presentation is held on the ACE website.

Initial Feedback

From a comparison of two bids prior to TC 6/2013 and two bids assessed under it, it would appear that under TC 6/2013 there has been a significant increase in staff rates used to build up lump sum fees. The Lump Sum Fees also seem to have increased. All of this is positive for our industry.

Primary Concerns

The seminar also provided a very useful discussion forum where the following primary concerns were raised:

- · How to sustain the momentum?
- Despite the increase, the "new" rates were still lower than normal charge rates
- · What is the next step forward?

Next Stage

It was concluded that a further workshop be held in about 3 months when the results of more bids will be available. Suggested issues for discussion include:

- Is there a need for two sets of rates (one for building up the Lump Sum fee and one for additional services)?
- · Is there a better way to mark fee quality?
- Can the complicated assessment method be simplified?
